


22 Farida — Mixed Use

22 Abdel Khalek Tharwat Street

The 22 Abdel Khalek Tharwat building occupies a special space in the league of Downtown Cairo relics. This 100-year-old, six-story building was dreamt up by a Greek family and designed to emulate the neo-classical architecture that was all the rave back in the 1920s. Overlooking three streets, Abdel Khalek Tharwat, Talaat Harb, and Adly, it soars above the bustling heart of the city and has become a beacon of inspiration for artists and creators.

Al Ismaelia for Real Estate Investment acquired the building in 2009, it consists of five floors with a rooftop. The Farida building creates an inspiring space where art and architecture can beautifully collide to inspire new tenants and initiatives. It hosted the “Contemporary Image Collective” (C.I.C), an independent art initiative, which made the building an attraction point to artists and creatives. In 2022, the building was branded and renovated once again.



10 Mahmoud Bassiouni – Serviced Apartments

10 Mahmoud Bassiouny Street

The 10 Mahmoud Bassiouny building stands as a fine example of early 20th-century Downtown Cairo architecture, characterized by its elegant balconies, intricate ironwork, and harmonious proportions. Originally built during Cairo's cosmopolitan boom, the building reflects the city's shift toward European urban planning while maintaining its distinctly Egyptian character. It was designed in 1934 by Italian architect G. E. Falorni and was sold to Edward Tamraz in 1942.

Al Ismaelia for Real Estate Investment acquired the property in 2009 as part of its broader vision to restore the residential fabric of Downtown. Since then, the company has undertaken structural and architectural studies to safeguard the building's heritage value while preparing it for adaptive reuse.

With Knight Frank as Al Ismaelia's advisory partner. The development plan reimagines 10 Mahmoud Bassiouny as a serviced apartment building, bringing new life to its historic walls through contemporary comfort and hospitality. By merging preservation with modern living, the project aspires to revive the building's original spirit, that of refined urban residence in the heart of Cairo.



33 Sherif — Mixed Use

33 Sherif Street

Built in 1913, the building at 33 Sherif Pacha Street is one of Downtown Cairo's oldest landmarks. With its neo-baroque, Beaux-Arts design and distinctive 45-degree façade overlooking Abdel Khalek Tharwat Street, it reflects the elegance of early 20th-century Cairo. Originally housing apartments and shops, it remains a testament to Downtown's blend of heritage, commerce, and culture.

Acquired by Al Ismaelia for Real Estate Investment in 2010, the property forms part of the company's ongoing commitment to preserve Cairo's architectural legacy while reintroducing it into modern urban life. It has become a creative spot for filmmakers and artists using it as both a backdrop and scene-stealer in their stories.



29 Hoda Shaarawy – Hotel

29 *Hoda Sha'arawy Street*

Located at 29 Hoda Sharaawi Street, the Riche Building was founded in 1908 and later acquired by Frenchman Henry Recine in 1914. Over the decades, it changed hands several times, with each owner adding to its legacy, from a café and theater to a world-class restaurant. “Café Riche” became a landmark of Downtown Cairo’s cultural life, serving as a gathering place for leading Egyptian writers and intellectuals and a hub for political and artistic movements, including the 1952 revolution.

Al Ismaelia for Real Estate Investment acquired the property in 2008, recognizing its historical and cultural significance as a cornerstone of Cairo’s identity. The Hoda Sharaawi building includes four floors and a rooftop. With great care, Al Ismaelia is preserving its architectural integrity.

The development plan envisions transforming the 29 Hoda Shaarawi Building into a hotel, maintaining the authenticity of its historic features while introducing contemporary hospitality standards. This adaptive reuse aims to ensure that Café Riche continues to be a living part of Downtown’s story, where heritage, memory, and modern life coexist seamlessly.



Cinema Radio – Mixed Use

24 Talaat Harb Street

One of Downtown Cairo's most iconic landmarks, Cinema Radio embodies the city's cosmopolitan spirit. Built in 1932 by architects Max Edrei, Garo Balyan, and Victor Salama, it originally featured Cairo's largest theater screen. In the 1970s, it was divided into a cinema and a theater. Over the decades, its halls have premiered celebrated Egyptian films, hosted Umm Kulthum, and served as a backdrop for landmark boutiques.

Al Ismaelia for Real Estate Investment acquired the building in 2009. The restoration was completed by 2015 and designed in collaboration with Hassan Abouseda Architects. Some of the most notable figures to fill the space since are Bassem Youssef with his show "Al Barnameg" in 2011, and TV talk show "Abla Fahita". Currently, the building hosts multiple screenings and events, while also hosting office, retail, and F&B spaces.

In collaboration with Al Ismaelia for Real Estate Investment, GNK group will be introducing "Samara", a "theatro" concept within the theater space at Cinema Radio by the end of 2026.



Consoleya – Co-Working Space

5 Al Fadl Street

Located at 5 Al Fadl street, Consoleya, which was once The French Consulate, reflects a neo-baroque architectural style, infused with minimal eclecticism. The building was moved from Galal Street in Azbakeya to its current location in 1925, when French architect Paul-Conin Pastour was assigned for the construction of the existing building. The result was a four-story gem, boasting a spacious garage, and an elegant rooftop.

In 2014, Al Ismaelia for Real Estate Investment acquired the French Consulate and restored it in 2019 to introduce Downtown's co-working space "Consoleya", catering to the growing segment of passionate entrepreneurs in Egypt, while providing an engaging and versatile workspace environment. It also hosts a vibrant mix of corporate, cultural, and creative events.



36 Abdel Khalek Tharwat – Mixed Use

36 Abdel Khalek Tharwat Street

Located on 36 Abdel Khalek Tharwat Street stands as a refined example of early 20th-century eclectic architecture, blending classical European details with local craftsmanship. Its ornate balconies, symmetrical façade, and finely proportioned windows reflect the elegance of Cairo's urban expansion during the 1920s and 1930s, a period when the city emerged as a cosmopolitan capital of art, commerce, and modern living. Over the years, the building has housed a diverse mix of offices and retail spaces, contributing to the district's dynamic commercial fabric.

Al Ismaelia for Real Estate Investment acquired the property in 2009 as part of its broader vision to revive Downtown's architectural heritage through adaptive reuse. With careful attention to its structural and decorative integrity, Al Ismaelia aims to restore the building's original grandeur while updating it for contemporary use.



Kodak — Mixed Use

20 Adly Street

Tucked away on 20 Adly Street, the Kodak Building is a landmark of Neo-Classical architecture, designed in 1928 by French archaeologist, architect, and historian André Godard. The seven-story building is distinguished by its two main entrances, marked A and B. In 1912, George Eastman, the inventor of Kodak, chose it as the site for Kodak HQ in Egypt and the Middle East.

Al Ismaelia for Real Estate Investment acquired the Kodak building in 2008. Kodak passageway is a linear space that connects Adly Street to Abdel Khalek Tharwat. In 2015, the passageway was renovated based on a design workshop organized by CLUSTER, in collaboration with the Danish Egyptian Dialogue Institute (DEDI), and the Centre for Culture and Development (CKU), providing more accessible and inclusive public spaces in Downtown Cairo.



Kodak Court – Mixed Use

20 Adly Street

Nestled on the ground floor of the historic Kodak Building, Kodak Hall once served as a lively commercial passageway and social gathering spot in Downtown Cairo. Dating back to the 1920s, the hall reflects the building's Art Deco influence, with its high ceilings, rhythmic arches, and intricate flooring that together create an atmosphere of understated elegance. For decades, it formed part of Cairo's bustling commercial heart — connecting passersby, shoppers, and photographers in one of the city's most active urban corridors.

Al Ismaelia for Real Estate Investment, which acquired the Kodak Building in 2008, has placed Kodak Hall at the center of its revitalization vision for Adly Street and the surrounding area. Building on its historical role as a meeting place, the company is transforming the hall into a vibrant food court and social hub that brings together a curated mix of local and international culinary concepts. The project aims to reestablish Kodak Hall as a destination for community, creativity, and culture — where Cairo's historic architecture provides the setting for contemporary urban experiences and collective memory continues to unfold.



La Viennoise – Mixed Use

7 Champollion Street

One of the most illustrious buildings in Downtown Cairo is La Viennoise. Situated at the lively intersection of 7 Champollion Street and 11 Mahmoud Bassiouny, this 129-year-old gem has long reflected Downtown's unique montage of aesthetics. Built in 1896 by an English architect, La Viennoise pays homage to timeless beauty, with its distinguished Italian renaissance architectural style continuing to shine through the decades.

In 2009, Al Ismaelia acquired La Viennoise to create Cairo's first green heritage building. Renovated in 2016, it earned the "Tarsheed Commercial Renovation" award for its sustainability standards. The building's restoration was designed in collaboration with Karim Mekhtegian – Founder of Alchemy, and Mohamed Said – Design Director and CEO of Ebony & Ivory and comprises four levels and a rooftop. Today, it houses Sarwa Capital, Contact Financial Holding, and Mazeej Balad, a boutique hotel blending Egypt's cultural heritage with modern design. With five unique suites and a rooftop restaurant overlooking the city, Mazeej Balad reflects Al Ismaelia's vision of reviving Downtown through adaptive reuse and creative renewal.

The courtyard will be a mixed-use space featuring local retail and F&B brands, designed in collaboration with Zaro Architects and Alchemy Group.



Layal – Serviced Apartments

24 Adly Street

Standing tall at 24 Adly Street, the Marcel Pissarro Building – now known as Layal – embodies a legacy of ambition and transformation. Built in 1930 during Downtown Cairo's golden age, it reflects the Art Deco style through bold geometric forms and curved ornamental windows. Originally owned by Menasché Mayer, the building rises six floors high.

In 2010, Al Ismaelia acquired Layal, recognizing its architectural and cultural value. Now operated by Lemon Spaces, it has been reimaged as serviced apartments for modern travelers—stylish, fully furnished, and designed for comfort and sophistication. With curated amenities and personalized service, Layal offers a refined home away from home in the heart of Cairo.



Shourbagy – Mixed Use

16 Adly Street

The Davies Bryan Building, known as El Shourbagy, is a 110-year-old Downtown Cairo landmark designed in 1910 by Welsh architect Robert Williams. With its red-brick façade and Neo-Islamic entrances, it overlooks Adly, Mohamed Farid, and Abdel Khalek Tharwat streets. Acquired by the Shourbagy Brothers in 1947, it still houses retailers like the iconic “Halawa” shop.

Al Ismaelia for Real Estate Investment acquired the building in 2008, later renovating and revamping the building entirely in 2015. One of the building's most sought after spots is its rooftop, which gives an inimitable view of Downtown Cairo's skyline. This pinnacle Downtown location has also served as a set for several projects, including; films, music videos, ads, and many more. Two of the most notable venues in the building are: “Villa Violette” and “Villa Victoria”.



Tamara Haus – Boutique Hotel

17 Gawad Hosny Street

Located at 17 Gawad Hosny street, Abdul-Aziz Radwan Bey (commercially known as Tamara) building was first completed in 1910 with a three-floor neo-renaissance architecture style. In 1912, two additional floors were added to the building. The building was first owned by Banque Misr, but in 1919, the ownership was transferred to Emili Jalica, who later sold it to Abdul-Aziz Radwan Bey in 1925.

Al Ismaelia acquired the building in 2009 and restored it in 2022. The building features four floors, along with a basement and a rooftop. Operated by Alchemy Experience, TamaraHaus blends design, art, retail, F&B, and hospitality into a vibrant cultural hub. At its center lies Tchai, a teahouse and courtyard celebrating cuisine, culture, and community. In 2025, TamaraHaus received Egypt's "Best Practices in Architectural and Urban Heritage Preservation" award under the Ministry of Culture's patronage.

By 2026, the property will evolve into a landmark of boutique hospitality with 26 suites, a dedicated fitness studio, and a rooftop restaurant that frames the grandeur of Downtown Cairo's skyline against the night sky, designed and operated by Alchemy Experience in partnership with Al Ismaelia.



The Factory — Mixed Use

6 El Nabawy Street

Originally a paper factory from the early 20th century, The Factory — later known as Townhouse Art Gallery — is a landmark of Downtown Cairo's contemporary cultural movement. The building's industrial architectural style, with its high ceilings, exposed brick walls, and open-plan layout, reflects Cairo's once-thriving manufacturing district and its adaptive potential for creative use. In the late 1990s, the space was transformed into Townhouse Gallery, one of Egypt's first independent art institutions, which played a pivotal role in shaping the region's modern art scene and connecting Cairo's creative community to international audiences.

Al Ismaelia for Real Estate Investment acquired the property in 2009, recognizing its historical and cultural resonance as a place where industry met art. The company's vision is to safeguard the site's industrial character while expanding its role as a mixed-use creative hub. The development plan reimagines The Factory as a space for studios, offices, exhibitions, and retail — preserving its legacy as a platform for innovation and artistic expression while ensuring its sustainable future within Downtown Cairo's urban revival.



The Warehouse – Mixed Use

2 El Nabarawy Street

Tucked behind the historic Cinema Radio complex, The Warehouse Building stands as a rare surviving example of early 20th-century industrial architecture in Downtown Cairo. Originally built to serve as a commercial storage facility, the structure's robust brick walls, open interiors, and utilitarian design embody the industrial spirit that once supported the city's bustling retail and entertainment district. Its understated aesthetic and spatial flexibility have long made it a hidden cornerstone of Downtown's urban fabric — a quiet counterpart to the grandeur of its neighboring façades.

Al Ismaelia for Real Estate Investment acquired The Warehouse in 2009, recognizing its potential to become a bridge between the area's industrial heritage and its creative future. The company's development plan envisions a mixed-use transformation, reimagining the building as a flexible complex hosting studios, retail outlets, and event spaces. Restoration works aim to preserve its raw architectural character while introducing modern amenities that encourage new forms of activity and collaboration. By reviving The Warehouse, Al Ismaelia continues its mission to unlock the latent potential of Downtown Cairo's overlooked spaces — turning history into a platform for contemporary urban life.



Garage – Retail

4 El Nabarawy Street

Situated near The Factory and The Warehouse, The Garage marks Al Ismaelia for Real Estate Investment's latest acquisition in Downtown Cairo's creative core. Originally built in the mid-20th century, the building functioned as an automotive garage — a reflection of the city's rapid modernization and industrial expansion during that era. Its modernist industrial architecture, defined by exposed concrete beams, wide spans, and high ceilings, was designed for practicality and durability, embodying the efficiency of Cairo's mid-century commercial infrastructure.

Recognizing the building's raw character and strategic location within a cluster of revived heritage sites, Al Ismaelia acquired The Garage in 2024 with a vision to extend its network of adaptive reuse projects. The development plan reimagines The Garage as a mixed-use space, integrating creative studios, retail concepts, and cultural venues within its industrial shell. By transforming this utilitarian structure into a vibrant destination, Al Ismaelia continues to bridge Downtown Cairo's industrial past with its evolving creative present — shaping a new ecosystem where heritage, innovation, and community converge.



Nabarawy Fashion Hub – Retail

6 El Nabarawy Street

Located on 6 Nabarawy Street, the Nabarawy Fashion Hub occupies a historic commercial building that once served as part of Downtown Cairo's bustling textile and retail district. Reflecting the neighborhood's legacy of craftsmanship and trade, the building embodies the spirit of Cairo's golden retail era, where local artisans and merchants shaped the city's commercial identity.


